MACKIN ENGINEERING COMPANY – MONTHLY ENGINEER'S REPORT

CARRIE FURNACE WATER LINE PROJECT WITH RAAC

No change. Construction of the water line is 95% complete. Remaining work is related to testing of the water line. Testing will not occur until all storm and sanitary work associated with the project are completed.

KENMAWR BRIDGE REPLACEMENT (RANKIN BOROUGH)

Golden Triangle has submitted shop drawings for review and they have been returned. Water line work not expected to occur in 2020.

CONE VALVE REPLACEMENTS (NADINE PUMP STATION)

Shop drawings are being reviewed and a meeting with manufacturer at site scheduled.

NEW METER PIT AT WATER TREATMENT PLANT

Lawson Excavating has completed the majority of the meter pit box. For the next two weeks, the concrete will be curing before the roof slab is poured. Progress is ahead of schedule. Water has been an issue for the entire construction cycle. Lawson has indicated they will be submitted for extra cost. Also, the pipe has been determined to be steel and not ductile iron. This will change the tapping method and require a saddle.

PENNSYLVANIA AVENUE WATER LINE REPLACEMENT (PITCAIRN)

Water line is complete and being utilized. Contractor needs to complete several punchlist items. No payment request has been received.

FRANKLIN AVENUE WATER LINE REPLACEMENT (WILKINSBURG)

During the first two weeks of February, the Contractor completed the three tie-ins to the existing system and the new water line is in use. Contractor needs to complete all concrete sidewalk and other repairs and place the binder. This work is weather dependent but should be completed in next 30 days.

FOURTH AVENUE WATER LINE REPLACEMENT (RANKIN)

A preconstruction meeting occurred with the Turtle Creek Council of Governments and Niando on February 12th. Niando expects to start work on March 6th. They expect to be complete by the end of April.

THIRD AVENUE WATER LINE REPLACEMENT (RANKIN)

A preconstruction meeting occurred with the COG and Naccareti Construction on February 12th. They intend on waiting to begin the project until the Fourth Avenue project is nearly complete to minimize traffic congestion and other construction related issues.

RAMSEY STORAGE BUILDING

JDL waiting on building drawings to submit to Authority and Borough.

MIXING SYSTEM FOR TANKS 2A/2B AND LOUGEAY

Request to advertise project for bid opening in March on agenda.

LOUGEAY ROAD TANK PAINTING.

Request to advertise project for bid opening in March on agenda.

ALUM STORAGE TANKS AT WATER TREATMENT PLANT

Kickoff meeting completed and site visit scheduled for the week of February 24th. Project on schedule for summer construction.

VERONA ROAD WATER LINE REPLACEMENT (PENN HILLS)

A meeting with PennDOT contractor, Pugliano Construction, scheduled for February 21st. A review of contractor's approach to streambank stabilization and location of water lines to be discussed. It is expected that the water line will need relocated in several locations.

BRADDOCK AVENUE EMERGENCY (EAST PITTSBURGH)

The Authority has experienced numerous (over 20) breaks since just before Christmas 2019 associated with the 6" cast iron line between O'Connell Boulevard and Main Street in East Pittsburgh. The Authority has made several repairs to the cast iron line and within a few days another break occurs. Due to the location of the last break and the condition of the pipe, the Authority was unable to complete a repair. The line was isolated and shutdown. With the shut, the Authority has lost redundancy to a large portion of the Authority. Based on the number of breaks and loss of redundancy, replacement of the line was determined to require emergency repair. A meeting was held with 4 contractors on Monday, February 10th and pricing was required by Wednesday, February 12th. The low bid was from Lawson Excavating for \$211,500. Lawson was notified to begin construction immediately. Traffic control and sawcutting were completed immediately and pipeline work will be started on February 25th. Pipeline installation is expected to be completed by the end of February.

ASPHALT PAVING CONTRACT

The 2020 Paving Contract is ready to bid. The current contracts have been cancelled after 3 years and will be combined into one contract.
