THE WILKINSBURG-PENN JOINT WATER AUTHORITY REPORT OF MANAGEMENT

November 28, 2023

- We are working on a Customer Assistance Plan for payment of Customer water bills only. There is a description of the program in your packet. The fee charged by Dollar Energy to administer the plan for the Authority is 8.75% of the payments approved.
- Authorization to award Contract 22-021 East McKeesport Water Tank
 Replacement to the lowest responsible bidder. Bid opening was October 20, 2023.
 Bid tabulation is in your packet.
- Management recommendation for the 2024 Operating Budget in the amount of \$34,500,000 and the Capital Improvement Budget in the amount of \$19,650,000.
 The recommended action will require a seven (7) percent increase in the Authority's residential, commercial, industrial, and public water rates.
- Recommend a five (5) percent increase for bulk water sale to the Braddock Water Authority effective January 1, 2024.
- Authorization to increase Executive Director and Assistant Executive Director salary as approved in Executive Session on October 24, 2023. Increase remainder of management base salary by an average of 3% effective January 1, 2024.
- Utility Billing System Training is ongoing for the new system. Go Live date is December 4, 2023. Office is scheduled to be closed for walk-in traffic on December 1 and December 4. We appear to be on schedule for conversion.
- The Policy Committee met to discuss changes to the Rules Booklet. The payment plans schedule has been changed to lower downpayment percentage and increase plan length, Same day turn-on fees, Private Fire Service Billing changing from quarterly to monthly and miscellaneous changes to Rules booklet to include credit card payments in Reversal Fees.
- Requesting authorization to award Contract 23-023, Furnishing and Delivering of Water Treatment Chemicals, to the lowest responsible bidder. Auction is scheduled for Friday, December 1, 2023. Award to be ratified at the January 23, 2024, regular scheduled meeting.
- Requesting approval to exercise renewal option Contract 22-020, Furnishing and Delivering of Water Treatment Chemicals, Liquid Aluminum Sulfate to USALCO at the price of \$549.99 per dry ton. Renewal is for the calendar year commencing January 1, 2024. All other contract terms and conditions to remain the same.
- Tyler Financials Inventory, Fixed Assets and Project Accounting are still in the process of being utilized. Trying to get historical data aligned in the three systems.

There are some minor problems with the payroll system. Will be working next month to get UMBS information to transfer in.

- Approval of Resolution No. 2023-04 allowing the Authority to apply for a Statewide Local Share Assessment Grant in the amount of \$950,000 from the Commonwealth Financing Authority to be used for the Replacement and Installation of Large Diameter Water Meters. Application is due November 30, 2023.
- There has been a total of 41 breaks since our October 24, 2023, meeting. Included in your packet is a breakdown by Municipality of all Distribution Work done during the last period.

PENNVEST LEAD SERVICE LINE PROJECT

JetJack has eliminated one crew and continues working with two crews. One of these crews will be moving to the Phase 2 project in the next couple of weeks. Total work completed to date is approximately \$6,000,000. Through November 16, 2023, approximately 1,150 services have been replaced. JetJack will continue with one crew until the grant money is spent. JetJack continues to have 2 or 3 restoration crews working on paving, sidewalks, and yard restoration. They have substantially reduced outstanding items over the last 3 months.

The updated listing of completed work by municipality is attached. JetJack has been focusing on Pitcairn and Wilmerding in the last 30 days. The attachment indicates that 66 service lines remain to be completed. We expect a majority of these to be complete by the end of 2023.

PENNVEST LEAD SERVICE LINE PROJECT - PHASE 2

Bova started working on November 6th. JetJack will start in the next couple of weeks. Starting next month we will provide a similar summary sheet to Phase 1. We will also provide a list of addresses included within Phase 2 and the work completed on a quarterly basis.

As of November 17th, we have received 870 agreement for Phase 2 (see attachment). This list does not include the agreements transferred to Phase 1.

Lawson Excavation has completed over 375 service lines. Although money remains available, work is paused as other work is started and additional addresses are identified. Work may be paused until early spring.
