PENNVEST LEAD SERVICE LINE PROJECT

Notice to Proceed for both contracts was issued as of March 1, 2022. M. O'Herron started work on March 7th and is making very slow progress. JetJack is having trouble with material and has not started yet.

To date, the Authority has received 412 signed agreements and has completed the inspection for 389 of the structures. Less than 10 homes have been identified as requiring homeowner action prior to the start of the work or have been canceled due to dangerous conditions. No additional agreements will be mailed for the foreseeable future.

DUFFIELD AREA WATER LINE PROJECT (PENN HILLS)

Contracts have been received and executed. Delivery time for the bid is 4 to 6 months. Based on this delivery time, the project will not start until mid-summer.

SERVICE LINE IDENTIFICATION PROJECT

Contract have been sent to the low bidder and we are waiting for partially executed documents. Once the contracts are executed, a preconstruction meeting will be scheduled and a notice to proceed issued. We expect the Notice to Proceed to be during the first half of April.

NADINE PUMP STATION METER VAULT EXPANSION

The project will be ready for bid by the end of March.

RAMSEY STORAGE BUILDING

We continue to work with Wilkinsburg Borough and Co—Stars contractor on the building permit issue.

CONE VALVES AT NADINE PUMP STATION

With the completion of the 16" and 20" cone valves in 2021, the next two 16" valves are scheduled for replacement. The project documents are currently being finalized and should be ready for bid in March. Delivery is expected to take 6 to 8 months.

NADINE PUMP STATION MOTOR AND VFD

Project ready for bid.

ALUM STORAGE TANKS AT WATER TREATMENT PLANT

Tanks and pre-fabricated metal building have been installed and interior work is nearly complete. Tanks should be ready for use some time in April...

WATER TREATMENT PLANT CLARIFIER COATING

In lieu of coating, we will be lining clarifiers. Project to be bid during 2nd quarter of 2022.

CARRIE FURNACE PHASE III PROJECT

JetJack Inc. was the low bidder for the Carrie Furnace Phase II project. We expect the RAAC to award the project. The start date will be dependent on the availability of materials.
